Booth spaces will not be reserved until full payment is received. NSF checks will be charged \$25.00 and no set-up will be permitted until NSF checks are made sufficient.

You will receive a confirmation with your booth number and location once your check clears the bank. Booth Spaces are 10ftX10ft

No refunds due to inclement weather. No refunds for cancelations after Sept. 15, 2012

Set-up time will be Thursday (20th) for spaces inside the tents, Friday (21st) for spaces outside the tents, and set-up must be completed with vehicles cleared by 4pm.

We do not allow the sale of soda pop, silly string, knives, lasers, firearms, or any other items or acts not mentioned herein that might be considered a violation of the laws or rules and regulations of the United States Government, the State of Indiana, the County of LaPorte, the Town of Wanatah or the Scarecrow Festival.

The following will not be permitted at the Festival or Festival Events

***Pets *Alcoholic beverages *Firearms *Smoking** (in tents/around booths)

Uniformed Security will be provided by the Festival.
