**September 6, 2019 is the deadline for application acceptance.**

**Booth spaces will not be reserved until full payment is received. NSF checks will be charged \$25.00 and no set-up will be permitted until NSF checks are made sufficient. A confirmation with your booth number and location will be mailed once your check clears the bank. Booth spaces are 10ft x 10ft**

No refunds due to inclement weather. No refunds will be given for cancelations after Sept. 20, 2019. Set-up time will be Thursday (26<sup>th</sup>) for spaces inside the tents, Friday (27<sup>th</sup>) for spaces outside the tents, and set-up must be completed with vehicles cleared by 3:45pm. We do not allow the sale of soda pop, silly string, knives, lasers, firearms or any other items or acts not mentioned herein that might be considered a violation of the laws or rules and regulations of the United States Government, the State of Indiana, the County of LaPorte, the Town of Wanatah or the Scarecrow Festival.

**The following will not be permitted at the Festival or Festival Events**

**\*Pets**

**\*Alcoholic beverages**

**\*Firearms**

**\*Smoking** (in tents/around booths)

Uniformed Security will be provided by the Festival.
