September 10, 2021 is the deadline for application acceptance.

Booth spaces will not be reserved until full payment is received. NSF checks will be charged \$25.00 and no set-up will be permitted until NSF checks are made sufficient. A confirmation with your booth number and location will be mailed once your check clears the bank. Booth spaces are 10ft x 10ft

No refunds due to inclement weather or cancellations due to local, state or federal mandates. No refunds will be given for cancelations after Sept. 10, 2021. Set-up time will be Thursday (23rd) for spaces inside the tents, Friday (24th) for spaces outside the tents, and set-up must be completed with vehicles cleared by 3:45pm. We do not allow the sale of soda pop, silly string, knives, lasers, firearms or any other items or acts not mentioned herein that might be considered a violation of the laws or rules and regulations of the United States Government, the State of Indiana, the County of LaPorte, the Town of Wanatah or the Scarecrow Festival.

The following will not be permitted at the Festival or Festival Events

***Alcoholic beverages**

***Firearms**

***Smoking** (in tents/around booths)

Uniformed Security will be provided by the Festival.
